Nonprofit Participation	<ul> <li>Charity Tour encourages participating Nonprofits to:</li> <li>Have at least one representative attend a training class and serve as a liaison;</li> <li>Promote ticket sales;</li> <li>Secure advertisers and sponsors, or sponsor yourself;</li> <li>Promptly transmit all sponsorship and ticket order forms to Charity Tour, along with the appropriate funds therefore, as directed by Charity Tour;</li> <li>Setup and operate a display at the event; and</li> <li>Encourage attendance at the event in your community by Nonprofit staff, donors, participants and volunteers.</li> </ul>

Promote Sponsorships & Advertising	The <b>Nonprofit</b> is encouraged to secure sponsors and advertisers for the Event. Donations	Charity Tour intends to solicit donations on behalf of the participating Nonprofits at each Event, and distribute all donations collected to the participating Nonprofits pro rata based on ticket sales by each Nonprofit.
