Nonprofit Participation	<p>Charity Tour encourages participating Nonprofits to:</p> <ul style="list-style-type: none"> • Have at least one representative attend a training class and serve as a liaison; • Promote ticket sales; • Secure advertisers and sponsors, or sponsor yourself; • Promptly transmit all sponsorship and ticket order forms to Charity Tour, along with the appropriate funds therefore, as directed by Charity Tour; • Setup and operate a display at the event; and • Encourage attendance at the event in your community by Nonprofit staff, donors, participants and volunteers. 				
Promote Ticket Sales	<p>Each Nonprofit will be assigned one or more unique "Magic Codes" which provide ticket purchasers with a discount of \$2 per ticket purchased. Charity Tour intends to award Nonprofit \$2 for every ticket purchased using a Magic Code of the Nonprofit.</p>				
Promote Sponsorships & Advertising	<p>The Nonprofit is encouraged to secure sponsors and advertisers for the Event. All sponsors and advertisers, and the terms of sponsorship and advertising, are subject to the approval of Charity Tour. Charity Tour plans to award 15% of all funds received from sponsors and advertisers who are identified with a Nonprofit to the Nonprofit organization.</p>				
Donations	<p>Charity Tour intends to solicit donations on behalf of the participating Nonprofits at each Event, and distribute all donations collected to the participating Nonprofits pro rata based on ticket sales by each Nonprofit. Nonprofit may sell various items or conduct other fund raising activities approved by Charity Tour, but may not solicit donations at the Event.</p>				
Displays and Event Activities by Nonprofit	<p>Charity Tour will provide participating Nonprofits with a table or display space in the lobby at the Event (<i>see community selection below</i>) and Nonprofit may use this space to share Nonprofit's message, solicit participants, solicit leaders, conduct a silent auction, sell fund-raising items, or other activities approved in advance by Charity Tour. Nonprofit may not sell food or beverage items to be consumed at the Event. Space at each Event is limited and Charity Tour reserves the right to limit the number of Nonprofit displays. As a result, some Nonprofits may not be able to display at the Event, with preference given to those Nonprofits with the most advance ticket sales, sponsorships and advertising as of the decision date determined by Charity Tour. All decisions by Charity Tour are final.</p>
